Consequent upon review of pending matters in the Directorate, it is stated that there is no independent Financial Advisor with core expertise and experience who can specifically scrutinise proposals and methodologies initiated from various divisions/wings branches till date in the office of the D. G (Shipping).

2. Further, there is no independent CVO for the office of the D.G (Shipping), the officer incumbent in the division / branch of Administration is also addressing CVO role and there are officials in specific roles and responsibilities wherein concerns have been raised on record with a vigilance angle addressing core functions.

3. As on date there is no monthly review of Finance and Accounts Division with no review of the utilisation of the budget.

4. In view of the above, in continuation to Office Order No.17 of 2024 dated 12.02.2024 and 22 of 2024 dated 13.02.2024 and other earlier issued work allocation orders, the Competent Authority has ordered the following with effect from 01.03.2024

(i) Work related to Crew Branch assigned to Shri Navanath R Raut, ADG and Shri Ramsajan Gupta, EO I/c are withdrawn with view a to exclusively focus on Finance & Accounts Branch effectively.

(ii) Work related to Shipping Development Branch assigned to Shri Navanath R Raut, ADG is also withdrawn in view of effective functioning of Finance & Accounts Branch.
