

Training Circular No. 7 of 2002

Sub: Recognition of certificates - (As per Regulation I/10 of STCW'95)

In accordance with the provisions under Regulation I / 10 of the STCW 95 convention an Endorsement in the prescribed format as per page 11 Section A - I / 2 of the Convention is required to be given to COC holders whose COCs have been accepted, pursuant to signing of the MOU. The format of the "endorsement" is given in the Convention but necessary format (Endorsement) is yet to be printed or a computer program is yet to be developed.

Considering the fact that there are many Indian officers holding UK COC are sailing on Indian ships and understanding that the PSC officers will be very severe during their inspection, with respect to compliance of STCW 95, it is essential that immediate temporary steps should be initiated so that such Indian ships having such COC holders are not detained.

Taking note of para 5 of Regulation I / 10 of the Convention, the certificate holder from the country with whom necessary MOU has been processed and completed may apply for endorsement. Such applicants may be given a documentary proof in the attached format to indicate that application for the endorsement has been submitted to the Administration. Such documentary proof will be accepted in lieu of the endorsement for a period of three months .

So far as the fees are concerned, Rs. 1000 may be charged for issuance of acknowledgement. The fee of 1000 is based on extension of para 21 of the schedule of fee as prescribed in the META Manual Vol. I.

In the beginning it may be restricted to Indian nationals intending to serve on board Indian ships. The applicant may fill up the application form at the examination center supported by a letter from the intending employer (Indian) for the purpose of acknowledgement letter.

The MMDs shall forward a copy of acknowledgement letter to the Directorate for the purpose of preparation of endorsement as per Regulation I / 10 of the Convention.

In view of above, till "**Endorsement Attesting the Recognition of a certificate**" is issued by Directorate, the POs are hereby authorized to issue the "Acknowledgement of Application".
