**ORDER**

Whereas, M/s Bravo Ship Management Pvt. Ltd (BSM) located at Tichel Bio Park-II, No. 907, 9th Floor, No. 5, CSIR Road, Taramani, Chennai – 600 113, was issued with Recruitment and Placement Service License bearing No. RPSL/CHN/038 valid from 19.01.2021 to 19.01.2026, by the Director, Seamen's Employment Office, Chennai, under the Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016, promulgated vide Gazette Notification G.S.R. 169(E) dated 15.02.2016.

2. Whereas, M/s Bravo Ship Management Pvt. Ltd. failed to respond for the queries in the application RPSL/ANNUAL/2022/8045 dated 07/02/2022 and has not rectified several inconsistencies in spite of repeated follow up. Hence, Show Cause Notice No. F.No. SEO/CHN/SCN/2019 dated 29/04/2024 was issued with the list of deficiencies, for which no reply received.

3. Whereas, M/s Bravo Ship Management Pvt. Ltd. did not initiate inspections for the subsequent two years 2023 and 2024 annual inspections within the prescribed timelines, which is in Violation of 5 1(z) of MS RPSL Rules, 2016.

4. Whereas, M/s Bravo Ship Management Pvt. Ltd. Mumbai Office vide email dated 07/10/2024, requested to enhance their BG from 10 Lakhs to 15 Lakhs. On querying, it was informed that they are operating from Mumbai office for few months, this too was not communicated and updated in the RPSL profile online. Hence DSEO, Chennai, recommended/requested the DGS, Crew Branch to block the online privilege, accordingly on 25-10-2024 the online privilege was blocked.

5. Whereas, based on M/s Bravo Ship Management Pvt. Ltd., request and SEO, Chennai recommendation the RPSL profile was activated by DGS, on 11-12-2024, enabling the BSM to update/upload the rectified documents and complete the due annual inspections.

6. Whereas, personal hearing was conducted on 27.01.2025 under Rule 12(2) of the MS (RPS) Rules, 2016. In the hearing, the representatives of BSM Viz. Capt. B. B. Sinha, Director and Shri. Nandkishor Manjrekar, General Manager, Fleet Personnel informed their intention to surrender the RPS licence and will re-apply to DSEO, Mumbai. However, this intent was later withdrawn by RPS vide email dated 15.04.2025. In view of the changed position, a second hearing was held on 07.05.2025.

7. Whereas, during the second hearing on 07.05.2025, the representatives of BSM Shri. Nandkishor Manjrekar, General Manager, Fleet Personnel and Shri. Senthil Kumar Director admitted their lapse in compliance, citing internal mismanagement, and assured that all pending inspections would be completed at the earliest. It was also affirmed that the Chennai office would remain the registered/main office and Mumbai office will remain as a branch.

8. Whereas, RO recommended the application # RPSL/ANNUAL/2022/8045 dated 07.02.2022 which was approved on 06.06.2025 and DGS Crew branch was requested to unblock the online privilege. Application RPSL/ANNUAL/2025/22807 dated 11.06.2025 combined inspections for the years 2023, 2024 & 2025 was also recommended by RO and the same was approved on 29.07.2025. BSM's sign on privilege was unblocked/activated by DGS on 12-08-2025.

9. Whereas, RPSL, vide email dated 06.08.2025, intimated their change of place of business to Mumbai : Unit No. 502, 5th Floor, A Wing, Business Square, Andheri-Kurla Road, Chakala, Andheri East, Mumbai – 400093 along with lease agreement dated 13.04.2025.

10. Whereas, this office vide mail dt. 13-08-2025 has also informed that the warning letter No. 85/SEO/CHN/2016/Vol-I/D/1986 dated 06.08.2025, issued by speed post to the registered address of M/s Bravo Ship Management Pvt. Ltd., Chennai 600113 was returned by the Postal Department with the remark 'LEFT'.

11. Whereas, this office replied on 13-08-2025 that 'Change of Address' application for the Mumbai address is not feasible, since RPSL No. RPSL/CHN/038 issued to M/s Bravo Ship Management Pvt. Ltd., falls under the jurisdiction of DSEO, Chennai. However, it was advised that the Mumbai office may be operated as a branch office, in case the company wishes to continue with the RPSL issued by this office, under intimation to this office.

12. Whereas, M/s Bravo Ship Management Pvt. Ltd. vide their letter No. BSMPL/RPS/RK/003 dated 21.08.2025 received in this office through email dated 02.09.2025, submitted that their registered office is being changed to Mumbai's jurisdiction and would like to surrender their RPS License, and also stated that currently they had not recruited any seafarer on board vessel.

13. In view of the above, the Director, Seamen's Employment Office, Chennai, hereby withdraw the Recruitment and Placement Service License bearing No. RPSL/CHN/038 issued to M/s Bravo Ship Management Pvt. Ltd. with immediate effect. However, the Bank Guarantee for Rs. 10 Lakhs shall be returned to M/s Bravo Ship Management Pvt. Ltd. upon meeting the compliance requirements.
