

ORDER

29 APR 2025

Whereas, M/s. Deep Horizen Marine Pvt. Ltd., a recruitment and placement service license has been issued a license bearing No. RPSL-MUM-162168 for the period 03.07.2023 to 03.07.2028 by the Director Seamen's Employment Office, Mumbai under Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 promulgated vide Gazette Notification GSR No. 169 (E) dated 15.02.2016.

2. Whereas, M/s. Deep Horizen Marine Pvt. Ltd. has failed to comply with the following provisions for following:-

2.1. Whereas, information received from the Indian Mission in Tehran to this office that the seizure of the vessel MT RANIAH at Bandar-e-Emam Port in Khuzestan Province of Iran since January 2024 with 9 Indian seafarers. However, the same was not intimated within the stipulated time period to this office by the RPSL, which is in violation of Rules 5(1) (j) of MS (R&PS) Rules, 2016.

2.2 Whereas, M/s Deep Horizon Marine Pvt. Ltd., failed to promptly and adequately respond and inform the Director-General of Shipping, Mumbai about the unresolved complaint, which is in violation of Rule 5 (1) (f) of MS (R&PS) Rules, 2016.

2.3 Whereas, it is also revealed that the Form-I of Shri. Praveen Kumar CDC No. KOL 120468 updated at vessel MT TABARK, however seafarer was placed on vessel MT RANIAH, which is not uploaded in RPS profile by RPS company, thus RPS Agency violate the Rule 5 (1) (a) & (m) of MS (R&PS) Rules, 2016.

3. Whereas, this office issued a Show Cause Notice under Rule 12 (1) of M.S. (R & PS) Rules, 2016 to M/s. Deep Horizen Marine Pvt. Ltd., vide letter dated 10.06.2024 & 24.07.2024 for non-compliance of M.S. (R & PS) Rules 2016 and simultaneously the online privileges of RPS Agency to sign on seafarer were suspended w.e.f 06.06.2024 in the interest of seafarer safety and security. Following non response to this office SCN, a personal hearing was scheduled under Rule 12(2) of the said rules on 11.04.2025.

4. Whereas, the following were submitted by the RPSL during aforesaid hearing:

4.1 With reference to violation noted in Para No. 2.1 of above, the RPS Agency stated that they have received information from the Indian Mission in Tehran regarding the seizure of the vessel MT RANIAH at Bandar-e-Emam Port Khuzestan Province, Iran, since January 2024, with nine Indian seafarers. Notably, Mr. Praveen Kumar, a crew member, was safely repatriated and returned to India on 09.07.2024.

4.2 Further stated that Mr. Praveen Kumar Form-I of CDC No. KOL 120468 was updated while they were serving on vessel MT TABARK, but was later found onboard vessel MT RANIAH, without the corresponding update in the RPS Company. The Owner of the vessel shuffled the crew within their sister concern company of another vessel and neither the owner nor the crew members informed them.

5. Whereas M/s. Deep Horizen Marine Pvt. Ltd vide its letter dated 17.04.2025 has requested the surrender of its license and the release of the bank guarantee of INR 30 Lakhs submitted under Rule 15 of the Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016, in light of the withdrawal of the RPS license.

6. Whereas from RPS response in all aforesaid matter it is concluded that M/s. Deep Horizen Marine Pvt. Ltd., has no valid explanation to tender in the matter and it is evident that M/s. Deep Horizen Marine Pvt. Ltd, has violated rule 5(1) (a), (f), (j) & (m) under Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 promulgated vide Gazette Notification GSR No. 169 (E) dated 15.02.2016.

7. Based upon detailed proceedings conducted in the matter and in view of all the above, the Director, Seamen's Employment Office exercising the power vested upon them in accordance with Rule 12 of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 orders Following:

7.1 Recruitment and Placement Service Licence bearing No. RPSL-MUM-162168 valid from 03.07.2023 to 03.07.2028 in respect of M/s. Deep Horizen Marine Pvt. Ltd. is hereby withdrawn by the Director, Seamen's Employment Office, Mumbai in terms of Rule 12 of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 with immediate effect.

7.2 M/s. Deep Horizen Marine Pvt. Ltd & its associates Directors shall continue to remain liable for the seafarers who have already been recruited by them and seafarers who are presently serving on board.

7.3 The submitted Bank Guarantee amounting to INR 30,00,000/- (Rupees Thirty Lacs only) of M/s. Deep Horizen Marine Pvt. Ltd. is withheld under the custody of this office for any contingent issue due to default/violation of extant Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 by M/s. Deep Horizen Marine Pvt. Ltd.

8. If, M/s. Deep Horizen Marine Pvt. Ltd., (RPSL-MUM-162168) is aggrieved by the order passed, may within a period of thirty days of receipt of this order, appeal to the Principal Officer, Mercantile Marine Department, Mumbai being the First Appellate Authority in accordance with Rule 19(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules 2016 it may be noted that Rule, 18 mentioned under Rule 19(1) of Merchant Shipping [Recruitment and Placement of Seafarers) Rules, 2016 is to be read as Rule 12 in view of typographical error in Gazette Notification No G.S.R. 169 (E) dated 15.02.2016].
