Subject : **Filling up the 3 posts of Assistant Director General of Shipping in the Directorate General of Shipping, Mumbai in the pay scale of ₹15600-39100 + Grade Pay ₹ 6600 /- by deputation.**

It is proposed to fill up 3* posts of Assistant Director General of Shipping which are likely to be fallen vacant in the near future in the office of the Director General of Shipping, Mumbai through deputation. The essential qualification, experience etc. required for the post are given in the enclosed **[Annexure-I: 3 Pages]**. The period of deputation, including the period of deputation in another ex-cadre post held immediately preceding this appointment, in the same organization/department, shall not ordinarily exceed(four) 4 years.
