WITHDRAWAL ORDER

Whereas, M/s. SM Ship Management Private Limited was issued with Recruitment & Placement Service (RPS) Licence bearing No. RPSL-MUM-224 valid from 01.11.2012 to 17.08.2021 by the Director, Seamen's Employment Office, Mumbai under Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016.

2. And whereas, the said RPS license No. RPSL-MUM-224 in respect of M/s. SM Ship Management Pvt. Ltd. stand expired w.e.f. 17.08.2021 and RPS agency has not applied for renewal of RPS license till date, which is in violation to Rule 9(2) of M.S. (R&PS) Rules, 2016 Quote "An application for renewal shall be submitted within six months prior to the date of expiry of licence." End quote.

3 And whereas, various documents submitted / uploaded by RPS agency has already expired i.e. Bank Guarantee, MLC, P & I certificate, Financial Certificate, Form-VII, Manning Agreement etc. which is in further violation of Rules 15 and 9(2) of M.S. (R&PS) Rules, 2016.

4. And whereas, RPS agency has failed to comply with Rule 5, 9(2) and 15 under M.S. (R & P.S.) Rules 2016 to be read with DGS Notice No. 06 of 2018 dated 11.10.2018 and DGS Circular 02/2019 dated 12.06.2019.

5. And whereas, this office continued to receive grievances from various seafarers regarding non-payment of wages, taking of service charge and seafarers recruited by RPS agency being stranded onboard. The same were taken up with RPSL agency, however RPS agency, failed to respond adequately to the grievances and thereby, has failed to undertake its responsibilities under M.S. (R&PS) Rules, 2016.


6. Therefore, it is concluded that M/s. SM Ship Management Private Limited has no valid explanation to tender in any of the aforesaid matters and it is evident from above that M/s. SM Ship Management Private Limited is guilty of violation of various provisions / rules under Merchant Shipping (Recruitment & Placement of Seafarer) Rules, 2016 promulgated vide Gazette Notification GSR No. 169 (E) dated 15.02.2016.

7. In view of the above, the Recruitment and Placement Service Licence bearing No. RPSL-MUM-224 valid from 01.11.2012 to 17.08.2021 in respect of M/s SM Ship Management Private Limited is hereby withdrawn by the Director, Seamen's Employment Office, Mumbai under Rules 12 of Merchant Shipping (Recruitment & Placement of

Seafarer) Rules, 2016 with immediate effect. However, M/s. SM Ship Management Private Limited and its associated Directors continue to remain liable for the seafarers who have already been recruited by them and those who remain presently onboard.

8. If, M/s SM Ship Management Private Limited is aggrieved by the order passed, may within a period of thirty days (30 days) of receipt of this order, appeal to the Principal Officer, Mercantile Marine Department, Mumbai being First Appellate Authority in accordance with Rules 19(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016. [It may be noted that Rule 18 mentioned under Rules 19(1) of Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 is to be read as Rule 12 view typographical error in Gazette Notification No. G.S.R. 169 (E) dated 15.02.2016].

9. This issue with the approval of Director Seamen's Employment Office, Mumbai.
