

Sub: Revised Status as on 31st December 2013 of approved for Non-IG Insurance Companies/Protection & Indemnity Clubs under Rule 2(e) of the Merchant Shipping (Regulation of Entry of Ships into Ports, Anchorages and Offshore facilities) Rules 2012- (Ship Entry Rules, 2012) notified vide G.S. R. 311(E) on 20.04.2012.

The Directorate General of Shipping, Mumbai has evaluated applications for authorization to Non-IG Insurance Companies under the provision of Rule 2 (e) of the Merchant Shipping (Regulation of Entry of Ships into Ports, Anchorages and Offshore facilities) Rules 2012. The Ministry of Shipping, Government of India vide rule 2 (e) of Ship Entry Rules, 2012, has recognized P & I Insurance issued by 13 nos. International Group of P & I (IG P&I) Clubs. In addition, the Ministry of Shipping, Government of India has approved 13 nos. other Insurance Companies (Non-IG). The present status of approval given to these Non-IG Insurance companies is stated below:

- (i) QBE Insurance (Europe) Limited represented by British Marine approved for a period of 5 years as Designated Insurer w.e.f. 5th December 2012. The approval is valid till 4th December 2017.
- (ii) Amlin Europe N.V. represented by RaetsMarine Insurance B.V. approved for a period of 5 years as Designated Insurer w.e.f. 5th December 2012. The approval is valid till 4th December 2017.
- (iii) Korea Ship Owner Mutual Protection and Indemnity Association approved for a period of 5 years as Designated Insurer w.e.f. 5th December 2012. The approval is valid till 4th December 2017.
- (iv) Royal & Sun Alliance (RSA) Insurance with underwriting agency Lodestar Marine Limited approved for a period of 5 years as Designated Insurer w.e.f. 8th January 2013. The approval is valid till 7th January 2018.
- (v) Korea Shipping Association (KSA Hull -P & I) approved for a period of 5 years as Designated Insurer w.e.f. 5th December 2012. The approval is valid till 4th December 2017.
- (vi) Ingosstrakh Insurance Company, Russia approved for a period of 5 years as Designated Insurer w.e.f. 8th January 2013. The approval is valid till 7th January 2018.
- (vii) Hellenic Mutual P & I and War Risk Association approved for a period of 5 (Five) years as Designated Insurer w.e.f. 28th March 2013. The approval is valid till 27th March 2018.
- (viii) Navigators Insurance Company approved for a period of 5 (Five) years as Designated Insurer w.e.f. 28th March, 2013. The approval is valid till 27th March 2018.

- (ix) M/s Hanseatic Underwriters, Germany approved for a period of 5 (Five) years as Designated Insurer w.e.f. 28th March, 2013. The approval is valid till 27th March 2018
- (x) OSPREY Underwriting Agency Ltd. - approved for a period of 5 (Five) years as Designated Insurer w.e.f. 8th January 2013. The approval is valid till 7th January 2018.
- (xi) British European and Overseas P & I Facility (BE &O) approved for further period of 1 (one) year w.e.f. 7th January 2014. This approval is now valid till 6th January 2015.
- (xii) M/s Moallem Insurance Co, Iran - short-term conditional approval extended for six (6) more months w.e.f. 27th December, 2013. The approval is now valid till 26th June 2014.
- (xiii) M/s Kish P & I Club, Iran - short-term conditional approval extended for six (6) more months w.e.f. 27th December, 2013. The approval is now valid till 26th June 2014.
