

Subject: Corrigendum II to Engineer Circular No. 125 of 2014 (Requirements to complete Part-A Extra First Class Course before enrolling in Part-B Extra First Class Course)

1. Noting that different interpretation exists among the D.G.S approved Institutes in meeting the requirements contained in Section 4(3)-Assessment of Engineering circular no. 125 dated 19th August 2014.
2. Realizing that varied interpretation of the said section has resulted disagreeing views among the stake holders and hence there is a need to provide clarification to ensure uniform interpretation and application of section 4(3)-Assessment of Engineering circular no. 125 dated 19th August 2014.
3. Realizing further that the completing the Part A course, conducted by the DGS approved institute, is needed before the enrollment of students into Part B course of Extra First Class and this requirement needs to be fulfilled, the Section 4(3) of Engineering circular no. 125 dated 19th August 2014 has now been amended to clearly specify the foregoing requirement and shall now to be read as following:

“The Examinations for all subjects is expected to be conducted by The Directorate General of Shipping, twice in a year i.e., in June and December every year. However, the candidates applying for the examination have to satisfactorily complete the course for the respective parts comprising minimum of 5 subjects, including the assignments, if any, as per the schedule prescribed by the institute, but in any case before 15th May and 15th November, respectively. No candidate should be enrolled in Part B unless he has completed Part A course including requisite part A assignments.”
4. Henceforth all the DGS approved institutes conducting the Extra First Class course has to ensure that no candidate is enrolled directly into Part B without completing Part A course and also to ensure that the candidates are provided with course completion certificate for the concerned part only after having verified that at least 5 subjects in each part has been satisfactorily completed.
5. Candidates who have enrolled directly into Part-B before the date of issuance of this circular will be considered for examination upon completing Part-A course.
6. This circular is issued with the approval of competent authority and will come into effect from the date of issuance.


